

Employment Services

Employment Services 2022 Impact

Open to participants aged 14 years and older, Employment Services assists individuals who have diverse abilities to achieve more independent lives by gaining and retaining competitive employment.

Our Employment Services team continues to adopt creative strategies to make back-to-work or new-to-work transitions successful.

Independent Living

Independent Living 2022 Impact

The Independent Living program assists adults with disabilities to live as independently as possible in the community. Individualized services include finding accessible and affordable housing, arranging transportation, financial management skills training, health care coordination, and daily living skills training.

In 2022, staff and participants were thrilled to begin gathering again for social engagement events.

Through the generosity of the Forest County Potawatomi Foundation, Broadscope was able to host several in-person events that allowed participants to experience new and exciting activities and venues.



Respite Care Coordination

Respite Care Coordination 2022 Impact

The Respite Care Coordination program is critical to the well-being of the entire family. Parents and caregivers of children and adults with disabilities are constantly providing care and advocating for their loved ones. Respite care provides a break for errands, appointments, quality time with siblings or a spouse, and a general recharge. Broadscope assists families in coordinating respite care with the provider of their choosing, either referred by Broadscope or identified by the family, ensuring they have someone they can trust caring for their loved one.

Representative Payee

Representative Payee 2022 Impact

The Representative Payee program provides services for people with disabilities who receive Social Security or Disability income and who have been identified as needing assistance managing their benefits. We ensure clients are protected from financial exploitation and that funds are being used appropriately and in their best interests.

Taste of Milwaukee

Virtual Taste of Milwaukee with a Side of Trivia was held on Thursday, March 10. Broadscope supporters formed trivia teams and competed to claim the Trivia Master Title. Trivia format allowed all team members to be in separate locations and answer questions on a phone or tablet. During trivia breaks, participants watched videos featuring testimonials from clients and saw how their support truly makes a difference in the lives of individuals with disabilities. VIP attendees were able to enjoy a cocktail and chocolate pairing from Indulgence Chocolatiers. Twenty-five teams (152 individuals) came together not only for a fun night of trivia but to advocate for a more inclusive community.

In 1997, this event was named in his honor, and Charlie and Dana continue to be honored through our annual golf outing. Joe's Run, Walk and Roll






Revenue
